INFORMATION

ON THE MORNING OF SATURDAY, 10/30/2004, AT APPROXIMATELY 1:48 A.M., WHILE WORKING AN EXTRA DUTY DETAIL AT 4000 RCA BLVD, PALM BEACH GARDENS FLORIDA 33410, THE SAFARI NIGHT CLUB. I, OFFICER E. GUILLEN WAS ADVISED BY CLUB EMPLOYEES, THAT THERE WAS A PATRON WHOM WAS CAUSING A COMMOTION INSIDE THE CLUB AND MANAGEMENT WANTED HIM REMOVED.

I ENTERED THE CLUB BEHIND THE EMPLOYEE, WAYNE BALL 07/01/1978, AND HE POINTED OUT A WHITE MALE OF APPROXIMATELY 50 YEARS, LATER IDENTIFIED AS JOHN S. KAZANJIAN, AND SAID "HE NEEDS TO GO!" OFFICER T. JURIC AND I APPROACHED THE SUBJECT AND ASKED HIM TO EXIT THE CLUB WITH US SO WE MAY DISCUSS THE MATTER OF HIS BEING ASKED TO LEAVE BY MANAGEMENT. THE SUBJECT VOLUNTARILY EXITED THE CLUB WITH US. ALONG WITH THE SUBJECT EXITED ANOTHER MALE AND SEVERAL OTHER PEOPLE. IMMEDIATELY UPON EXITING THE CLUB, THE SECOND SUBJECT BEGAN YELLING AT THE CLUB EMPLOYEE. THIS SUBJECT WAS VISIBLY INTOXICATED WITH BLOODSHOT EYES AND CLEARLY EMITTED THE ODOR OF AN ALCOHOLIC BEVERAGE FROM HIS BREATH. I APPROACHED THE SUBJECT AND ASKED HIM TO LOWER HIS VOICE AND PLEASE LEAVE THE PREMISES AS REQUESTED BY MANAGEMENT. OFFICER JURIC ALSO MADE SEVERAL ATTEMPTS TO CONVINCED THE SUBJECT, TO NO AVAIL. KAZANJIAN, ALTHOUGH VISIBLY UPSET, CONTINUED TO COOPERATE AND ASSIST US WITH GETTING THE SECOND SUBJECT CALMED DOWN.

WHILE OFFICER JURIC AND I ATTEMPTED TO GET THE SECOND SUBJECT AND OTHERS IN HIS PARTY CALMED DOWN, A MALE EXITED THE CLUB AND WHILE HE WAS WALKING AWAY FROM THE DOORS AND PAST ALL THE PARTIES INVOLVED, YELLED BACK, SAYING "GO HOME, JUST GO HOME!" UPON HEARING THE SUBJECT'S YELL, KAZANJIAN BECAME ENRAGED AND YELLED BACK: "FUCK YOU!" KAZANJIAN IMMEDIATELY ATTEMPTED TO RUN AFTER THE SUBJECT PUSHING ME IN THE PROCESS. OFFICER JURIC TOOK HOLD OF KAZANJIAN'S LEFT ARM AND ASSISTED ME IN RESTRAINING KAZANJIAN TO AVOID HIS CONTINUED AGGRESSION TOWARDS THE DEPARTING PARTY. KAZANJIAN TURNED HIS AGGRESSION TOWARDS ME AND CONTINUED TO PUSH AND YELL TOWARDS MY PERSON. KAZANJIAN YELLED "FUCK YOU, YOU PIECE OF SHIT!" AS I ASKED HIM TO CALM DOWN. KAZANJIAN RESPONDED BY SAYING "FUCK YOU, DON'T FUCKING TELL ME TO CALM DOWN, LET ME GO!" THE REST OF THE PEOPLE IN KAZANJIAN'S PARTY, APPROXIMATELY TEN IN TOTAL, BEGAN GETTING UPSET AND STARTED YELLING AT OFFICER JURIC AND I. AS THE CROWD SURROUNDED US I MADE THE DECISION TO PLACE KAZANJIAN UNDER ARREST FOR DISORDERLY CONDUCT, SECURE HIM IN HANDCUFFS AND ESCORT HIM TO A NEARBY POLICE VEHICLE FOR HIS AND OUR SAFETY. AS I HANDCUFFED KAZANJIAN I ASKED OFFICER JURIC IF KAZANJIAN WAS A LAW ENFORCEMENT OFFICER AND HE RESPONDED, "YES". WHILE OFFICER JURIC AND I ESCORTED KAZANJIAN TO THE VEHICLE, THE INTOXICATED SUBJECT THAT INITIALIZED THE DISTURBANCE IDENTIFIED HIMSELF AS A CAPTAIN WITH THE PALM BEACH COUNTY SHERIFF'S OFFICE AND ORDERED ME TO RELEASE KAZANJIAN WHO, ACCORDING TO THE FIRST SUBJECT, IS A SERGEANT WITH THE SAME AGENCY.

I IMMEDIATELY REQUESTED PALM BEACH GARDENS DISPATCH FOR A SUPERVISOR, AND WAS

ADVISED THAT SGT C. SANDS, SGT. G. CLAY AND LT. BLOOD WERE EN ROUTE TO MY LOCATION. DURING MY WAIT FOR THE ABOVE NAME SUPERVISORS, THE SELF IDENTIFIED CAPTAIN CONTINUED TO EXPRESS HIMSELF WITH PROFANITY AND ISSUED CONSTANT COMMANDS TO RELEASE KAZANJIAN. AMONG OTHER STATEMENTS, **THE CAPTAIN SAID IN A LOUD TONE, "I AM A CAPTAIN WITH THE PALM BEACH COUNTY SHERIFF'S OFFICE, THIS IS MY COUNTY! YOU WILL RELEASE THAT MAN NOW!"** I EXPLAINED TO THE CAPTAIN THAT I WOULD TAKE HIS REQUEST INTO CONSIDERATION, BUT I WAS WAITING FOR MY SUPERVISORS TO ARRIVE ON SCENE. EVEN AFTER I EXPLAINED TO THE CAPTAIN THAT THERE WERE SUPERVISORS ON THE WAY, HE ORDERED "I WANT THOSE SUPERVISORS HERE RIGHT NOW! DO YOU HEAR ME?" WHILE I ENTERTAINED THE CAPTAIN'S REQUESTS, OFFICER JURIC AND I WERE APPROACHED BY APPROXIMATELY 10 PERSONS OF KAZANJIAN'S PARTY, WHO WERE OBVIOUSLY INTOXICATED, AND CONTINUED TO ARGUE AND ATTEMPT TO APPROACH THE POLICE VEHICLE HOLDING KAZANJIAN. THESE PERSONS WERE CONTINUOUSLY ASKED TO BACK AWAY FROM THE VEHICLE AND DID NOT DEMONSTRATE COMPLIANCE. SOME OF THE INDIVIDUALS IN THE CROWD YELLED THAT KAZANJIAN HAD JUST LOST HIS DAUGHTER AND IT WAS NOT RIGHT THAT HE WAS ARRESTED.

UPON THE ARRIVAL OF SERGEANTS CLAY AND SANDS WITH LIEUTENANT BLOOD, THE SUPERVISORS ON SCENE SAW IT NECESSARY TO REQUEST ADDITIONAL UNITS FOR THE CONTAINMENT OF THE CROWD THAT HAD FORMED AROUND US. AFTER CAREFUL DELIBERATION ON THE MATTER, AND TAKING INTO CONSIDERATION THE FACT THAT KAZANJIAN WAS UPSET ABOUT HIS RECENT LOSS, IT WAS DECIDED TO RELEASE KAZANJIAN AND NOT PURSUE THE CHARGES HE WAS ORIGINALLY DETAINED FOR.

I WAS ABLE TO RETAIN SWORN WRITTEN STATEMENTS FROM CLUB EMPLOYEES DANIEL DEVOE, THOMAS PERUGINI, AND WAYNE BALL WHO ALL WITNESSED THE EVENTS DESCRIBED ABOVE. I ALSO OBTAINED SWORN WRITTEN STATEMENTS FROM SARA STEPHANOS, PATRICIA DELOSH, KATIE DELOSH, AND JAMES KAVNEY, ALL FROM KAZANJIAN'S PARTY. IN HIS SWORN WRITTEN STATEMENT KAVNEY STATED THAT HE SAW KAZANJIAN GRABBING A KID THAT WAS INVOLVED IN A SCUFFLE. KATIE DELOSH WROTE THAT SHE OBSERVED KAZANJIAN ARGUING WITH OFFICERS. PATRICIA DELOSH STATED THAT SHE SAW KAZANJIAN AND HE WAS NOT HAPPY AFTER THE MALE MADE THE "GO HOME" AND KAZANJIAN "WENT" AFTER THE SUBJECT BEING CONFRONTED BY OFFICERS. IT SHOULD BE NOTED THAT THESE PERSONS ALONG WITH SARA STEPHANOS, WHO ALSO OFFERED A STATEMENT, BELIEVE THAT KAZANJIAN DID NOTHING WRONG, AND DESCRIBE KAZANJIAN'S BEHAVIOR INSIDE THE CLUB AS DISRUPTIVE. DAN DEVOE STATED THAT KAZANJIAN POKED HIM IN THE CHEST TELLING HIM THAT HE WAS A SERGEANT WITH THE PALM BEACH COUNTY SHERIFF'S OFFICE AND THAT HE WOULD RUIN HIS LIFE. WHEN DEVOE ASKED THE SERGEANT WHAT HE WAS TALKING ABOUT, DEVOE EXPLAINS THAT KAZANJIAN RESPONDED BY SAYING "FUCK YOU!"

AT THE TIME OF THIS REPORT, KAZANJIAN WAS RELEASED WITHOUT INCIDENT. DEVOE DID NOT WISH TO PURSUE PROSECUTION FOR KAZANJIAN'S BATTERY UPON HIS PERSON, AND CLUB

ON SATURDAY 10-30-2004 AT ABOUT 0200 HOURS, I WAS WORKING AN EXTRA DUTY DETAIL AT CLUB SAFARI LOCATED AT 4000 RCA BLVD, PALM BEACH GARDENS, FLORIDA WHEN I WAS APPROACHED BY THE EMPLOYEES OF THE CLUB STATING THAT THERE WAS A PATRON INSIDE GIVING THEM PROBLEMS AND THEY WANTED HIM TO LEAVE. I WENT INSIDE AND MET WITH A WHITE MALE, LATER IDENTIFIED AS JOHN KAZANJIAN, A SERGEANT FOR THE PALM BEACH COUNTY SHERIFF'S OFFICE, WHO WAS TALKING TO OTHER EMPLOYEES OF THE NIGHT CLUB. I EXPLAINED TO KAZANJIAN THAT THE MANAGEMENT WANTED HIM TO LEAVE FOR THE EVENING AND HE REPLIED, "OK, LET ME GO BACK INSIDE AND GET MY WIFE." I FOLLOWED KAZANJIAN INSIDE OF THE CLUB AND HE RETRIEVED HIS WIFE AND LEFT. WHEN WE GOT OUTSIDE, A MEMBER OF KAZANJIAN'S PARTY, WHO IDENTIFIED HIMSELF AS A CAPTAIN BURKE FOR THE PALM BEACH COUNTY SHERIFF'S OFFICE AND WHO APPEARED TO BE VERY INTOXICATED, GOT INTO A VERBAL ARGUMENT WITH THE CLUB EMPLOYEE WHO HAD ASKED KAZANJIAN TO LEAVE. BURKE STATED THAT THE EMPLOYEE HAD "GOTTEN UP IN HIS FACE AND HE WANTED TO PRESS CHARGES." KAZANJIAN WAS ATTEMPTING TO CALM BURKE DOWN, PULLING HIM BY THE ARM STATING, "LETS GO. JUST DROP IT AND LETS GO." BURKE, STILL YELLING AT THE CLUB EMPLOYEE, STATED, "YOU DON'T KNOW WHO YOU ARE FUCKING WITH. I AM A POLICE OFFICER AND I WORK FOR THE SHERIFF'S OFFICE. I SHOULD PUT YOUR ASS IN JAIL MYSELF." I STEPPED IN BETWEEN BURKE AND THE CLUB EMPLOYEE AND ADDRESSED BURKE STATING, "SIR, PLEASE CALM DOWN." BURKE RESPONDED, "I AIN'T GONNA FUCKING CALM DOWN. I WANT TO PRESS CHARGES." I ASKED HIM WHAT HE WANTED TO PRESS CHARGES FOR AND HE STATED, "THAT SCRAWNY FUCK GOT UP IN MY FACE." AT THE SAME TIME, KAZANJIAN WAS PULLING ON HIS ARM STATING, "JUST LET IT GO MAN." I ASKED THE TWO MEN AGAIN TO PLEASE LEAVE WHEN AN UNKNOWN PATRON OF THE CLUB WALKED OUTSIDE AND SAID, "YOU ALL JUST NEED TO GO THE FUCK HOME." KAZANJIAN LET GO OF HIS HOLD OF BURKE AND STATED, "WHO THE FUCK DO YOU THINK THAT YOU ARE TALKING TO." THE INDIVIDUAL STATED, "I AM TALKING TO YOU." KAZANJIAN, HEARING THIS SAID, "MOTHERFUCKER" AND BEGAN TO CHARGE THE PATRON IN AN AGGRESSIVE MANNER, GOING AROUND OFFICER GUILLEN. OFFICER GUILLEN, FEARING FOR THE SAFETY OF KAZANJIAN AND THE PATRON, GRABBED THE LEFT ARM OF KAZANJIAN AND SAID, "SIR, CALM DOWN" KAZANJIAN STATED, "FUCK YOU, I AIN'T GONNA CALM DOWN." AND BEGAN TO STRUGGLE WITH GUILLEN. I GRABBED KAZANJIAN'S RIGHT ARM AND GUILLEN AND I PLACED KAZANJIAN AGAINST A PILLAR IN THE FRONT OF THE ESTABLISHMENT TELLING HIM TO CALM DOWN. KAZANJIAN, WHO WAS STILL STRUGGLING WITH GUILLEN AND ME, ATTEMPTING TO GET AWAY STATED, "FUCK YOU, I AIN'T GONNA CALM DOWN." I TOLD KAZANJIAN TO PLEASE CALM DOWN AND NOT MAKE THIS SITUATION ANY WORSE THAT WHAT IT ALREADY WAS. KAZANJIAN REPLIED, "YOU DON'T KNOW WHO THE FUCK I AM." OFFICER GUILLEN VERBALLY STATED TO ME, "THIS GUY HAS TO GO", A COMMON TERM AMONG LAW ENFORCEMENT OFFICERS MEANING THE SUBJECT IN SUBJECT WAS GOING TO

BE ARRESTED. OFFICER GUILLEN PULLED OUT HIS HAND CUFFS AND TOLD KAZANJIAN THAT HE WAS NOW BEING PLACED UNDER ARREST. KAZANJIAN ASKED WHAT HE WAS BEING ARRESTED FOR AND GUILLEN RESPONDED FOR DISORDERLY CONDUCT. KAZANJIAN WAS PLACED INTO HANDCUFFS AND WALKED BACK TO GUILLEN'S PATROL CAR. KAZANJIAN WAS STATING, "I KNOW YOUR CHIEF AND CAPTAIN WESNICK, YOU WILL REGRET THIS." KAZANJIAN WAS PLACED INTO THE BACK SEAT AREA OF THE PATROL VEHICLE AND GUILLEN CALLED FOR A SUPERVISOR TO RESPOND TO THE SCENE. ONCE SUPERVISORS SGT. SANDS, SGT. CLAY, AND LT. BLOOD, THE SCENE BECAME UNDER CONTROL. GUILLEN AND I EXPLAINED WHAT HAD TRANSPIRED TO THE SUPERVISORS AND TOLD THEM THAT THERE WERE OTHER PEOPLE IN KAZANJIAN'S PARTY THAT WOULD ENSURE THAT HE GOT HOME SAFELY. WE FURTHER TOLD THEM THAT WE (GUILLEN AND I) WOULD HAVE NO PROBLEMS RELEASING KAZANJIAN TO HIS FAMILY WITHOUT ANY CHARGES. KAZANJIAN, WHO HAD SINCE CALMED DOWN, WAS TAKEN OUT OF THE BACK OF THE PATROL VEHICLE AND UN-CUFFED. HE WAS RELEASED TO THE CUSTODY OF HIS WIFE WITH NO FURTHER ALTERCATION.
